#### KCOA PRESIDENT'S COMMENTS

DAVID RADCLIFFE, KILN CREEK BOD PRESIDENT

First, I hope all our Kiln Creek residents had a wonderful Holiday Season! In summary, I'd say we've had a VERY successful year. However, since my last article in the Spring edition of the Courier I may have been overly optimistic about the completion of our major project.

The main project for the year has become the refurbishment of the restaurant at the Club. Loan financing approval slowed down the construction start. Work on the project was not possible until late summer of 2017, but we are now coming up on completion in a few months. If you haven't been by the Club area in some time, please visit the facilities. You probably won't recognize the



old restaurant area - now called "NEST Kitchen & Taphouse". We expect the new restaurant to roughly double the seating of the previous facility, and it will offer different arrangements to fit both fine and casual dining. The cuisine will feature classic American dishes enhanced with international flavors! A sports bar area will serve innumerable craft beer varieties and will be an ideal place to watch the big game! The new arrangement will appeal to the variety of audiences we now serve – residents, hotel guests, golfers and all sorts of others. There will also be a new general-purpose room in the renovated building that will support Kiln Creek events and an expansion of our wedding business. Just think, if each household in Kiln Creek committed to one meal a month at NEST it would be a GREAT SUCCESS and benefit everyone in the community.

Several landscaping projects have been completed in recent months as we update and improve the look of the community. Work at the Club is very noticeable, and the entry to the facility now offers a much more effective welcome statement to

both the Club and the Hotel. Looking ahead to other landscaping projects this spring, we will be totally refreshing the three major entrances to Kiln Creek (one at Jefferson Ave and the two on Victory Blvd) in the same fashion as has already taken place at the Club. Keep your eyes open for the new, enhanced look!

Looking at our important business processes we now have a comprehensive, stable, and reliable budgeting process that operates on an annual cycle. The whole staff (HOA & Club staff) now work smoothly to implement this process. We also draw from our Strategic Planning list of projects that we may need to support with funding in the upcoming year. January through August information is collected and properly documented, primarily through the Strategic Planning Committee. This continues through the end of the calendar year but with this information we start developing the budget for the following year. We share our new budget with the Neighborhood Boards in October/November as a check on our thoughts. Then, we present a budget at our November BOD meeting, vote to approve it in open session, and post it on our website for several weeks before it becomes the active budget in January. This year the Budget discussion attracted a large community audience, which I felt was wonderful, and it led to good community interactions! NOTE: In 2018, we are required by HOA law to pay for an outside agency to do an independent Reserve Study. This is required every five years from every community association, and the process will help us determine the health of our Repair/Replacement Reserve funding. It also allows us to validate our Strategic Planning process and assuring the priority of our Strategic Planning Committee Project List. Many repairs and renovations have taken place in recent years, and the Reserve Study will help us identify future needs.

Finally, I'd like to briefly discuss Kiln Creek security. We have a camera system on the main roads running through the Community that has aided in the resolution of numerous incidents. In the coming year and years, we will be augmenting the quality of this system. That said, cameras are chiefly crime deterrent and resolution tools. More important to reducing and eliminating crime in Kiln Creek, are healthy and energetic Neighborhood Watch Programs. Such programs are the most proactive approach we have available to us and I encourage each neighborhood to establish a Neighborhood Watch. We have a volunteer who deals with either York County or Newport News law enforcement in helping you develop a system. Read about neighborhood watch on page 9 or contact the HOA office to get more information on participating in the Neighborhood Watch Program.

It's the time of year when things start slowing down a bit and we are able to pay attention to the things in our lives that mean the most to us. At the Association level, the Board and staff is certainly taking the time to concentrate on creating a better and more enhanced Kiln Creek again in 2018!

Over the last three months since the Oct/Nov/Dec issue of the Courier, we have been very busy making Kiln Creek the best community on the Peninsula! Although we have been focusing our attention on the renovation of NEST Kitchen & Taphouse, and building a beautiful new multi-purpose banquet facility, we have also been very busy in other aspects of the Community:

- We just finalized the 2018 Budget with no increase in Assessments for 2018.
- We have planned our 2018 Calendar of Events; see the next page and pages 20 & 21 for the Jan, Feb, March Calendar of events.
- We have been in contact with the City of Newport News, York County & VDOT regarding the pedestrian & bike study. We are hopeful to have the results within the next few months.
- We have also been in contact with the City of Newport News regarding the installation of a permanent lake pump by Dunhill. The plans have been approved by the ARB & Board; however, we are awaiting a Deed of Easement from the City for our Board to approve. Once this has been done, the City can begin planning its installation. This is great news for Kiln Creek, as a permanent lake pump will turn on automatically when the water levels get too high; which will then pump out the water into subsidiary creeks. This will drain our lake-system and keep water levels from getting to high during major storms.
- The HOA staff has been working random shifts on nights and weekends to ensure residents are adhering to our rules all times of the day. We are mainly looking for commercial vehicles, derelict or other vehicles not parked correctly, solicitation/for sale/open house signs that are displayed incorrectly, streetlight outages, and any other violations that we may happen to come across. We will soon be making sure holiday decorations are taken down at the appropriate time (no later than 14 days after the holiday).
- The 2017 Community Review process is nearing an end; however, that does not mean the process stops. We are continually performing reviews every day of the year. To read more about upcoming 2018 Community Review, please see page 12 for more details.
- The Strategic Planning Committee (SPC) has discussed the KC Strategic Plan, and there have not been any changes made this year. The current initiatives have not quite come to completion; therefore, we do not want to add anything else to our plate at this time. In late 2018, the SPC will take another in-depth look at all of the Associations needs and update the KC Strategic Plan again during the 2019 budgeting process.

In accordance with the amended Governing Documents, The Kiln Creek Annual Membership Meeting will be held this year on <u>Tuesday March 6, 2018 at 7:00 P.M.</u> at the **Kiln Creek Golf Club & Resort, 1003 Brick Kiln Blvd, Newport News, VA** (registration and refreshments will begin at 6:15 p.m). Last year we all had a great time at the annual meeting thanks to technology and a slide show presentation of our previous year's achievements. We plan to do the same again this year and hope you can come down to The Club to vote for your new Board members!

There are four (4) Board of Director positions open for the election. Five Board members, David Radcliffe, Jeffrey Verry, Martin Tate, Sandy Pullen-Droessler and James Ogden have another year to serve on the Board of Directors as long as they so choose to do so. If you would like to run for the Board, a nomination petition must be signed by Owners of at least three (3) Lots (other than the Lot owned by the Owner being nominated) and shall be submitted to the Board of Directors (KCOA Office) at least twenty-one days before the annual meeting or no later than **February 13**, **2018**. The petition shall include a certification signed by the Owner nominee which certifies that the Owner is willing to be nominated, that the Owner satisfies the eligibility requirements and that the information set forth in the candidate biography is true and correct. The nomination petition and biography form is part of your annual meeting packet that you should have already received. **Please note: Nominations from the floor at the Annual meeting are prohibited.** 

To be eligible to serve on the Board of Directors, Members and their Lots must be in good financial standing and must remain in good standing during the Member's term on the Board. Owners may not simultaneously serve on the Board of Directors while serving as members of any Neighborhood Advisory Board or Neighborhood Advisory Committee. Only Members who reside within the Villages of Kiln Creek are eligible to serve on the Board of Directors. Finally, Members running for elections must not be involved in a legal dispute with the Association at the time they seek appointment or at any time during their term. We look forward to seeing you at The Club for this year's Annual Membership Meeting! See you there!



The Association Board is looking for three to five volunteers to serve as inspectors for the upcoming election. This is a one-time commitment and an opportunity for you to serve your association in a meaningful way.

Our governing documents state that inspectors of election should be appointed from among the association members. But, even if they didn't, the board wants to be sure the election is conducted fairly and legitimately. Duties of inspectors will include examining proxies, tabulating votes and certifying their accuracy.

Members who have an interest in the election results are not eligible to serve as inspectors. This includes candidates, their family members, association officers or board members. We're looking for volunteers who are impartial.

## Annual Meetings: What is a Quorum and Why is it Important?

A quorum is the minimum number of owners who must be at an annual meeting before business can be transacted. State law tells us what that minimum number is for our association. It's relatively low at 292, but we still have a tough time getting to it. It's a common problem in many associations.

Meetings that don't have a quorum must be adjourned and rescheduled at a later date. This costs the association money and creates more work. And, achieving a quorum at a second meeting—if we couldn't get one the first time—is even harder.

So, why bother to try again? Because the board is legally obligated to conduct an annual meeting. It's an important part of conducting association business. During the annual meeting, new board members are elected and the associations financial position is presented to the homeowners. No quorum—no election. This means the current directors will have to continue serving until an election can be conducted.

Good news: You can be "at" a meeting and across the country at the same time by signing a proxy! That's how you assign your vote, in writing, to another person. Proxies count toward the quorum, so they're very important to the association.

We ask you to complete a proxy form, even if you plan to attend the meeting. That's just in case something comes up that prevents you from attending. And, when you do attend the meeting, your proxy will be thrown away.

Because proxies are so important to achieving a quorum, you may find us knocking on your door, calling on the phone, or even stopping you in the common areas asking you to sign a proxy form. We'll do anything to achieve a quorum. Without it, we can't do business, and eventually that affects you, the homeowner. Thank you for helping us achieve a quorum for the 2018 Annual Meeting!



## Decks and Patios

In this issue of the Courier, I wanted to take a moment to go over the items that are needed when submitting "Deck and Patio" applications for exterior alteration. According to the Architectural Review Board (ARB) Standards (Revised July 27, 2017): "All decks and patios require an ARB application."

Decks and Patios have a lot of specifications that need to be thought of when applying. Here is a guide for you to ensure all aspects of information are included in your application:



- You should include a plat showing the location of your house and the location of the proposed new deck or patio.
- You should also provide a drawing that shows the elevation of your house and the new structure, along with any stairs or railings that are to be installed. If railings will be installed, you will need to give a description of the material and what they will look like. You must give us the dimensions, and for a deck, the height above grade for the new structure.
- If you will be relocating any doors, windows or other structures (i.e. utility meters or A/C units), we ask that you explain it in detail and show on plat or drawing where they are currently located and where they will be moved.
- Please also explain any changes or additions to exterior lighting. The same applies to any removal, changes or addition of plants in conjunction with the new structure.
- If you will be staining a deck, a sample of the stain should be submitted with the application (unless you have checked with the HOA office and they have a sample on file of your stain). Decks and Patios may never be painted, only stained as stated above.
- If there will be a cover for the new structure, such as a Pergola, you must submit samples of the material and finish as you do for the deck or patio. Temporary gazebos/canopies require a separate application from the deck or patio, and must be anchored. If a temporary gazeebo is placed on a deck, it must be bolted to the deck.

Keep in mind, some neighborhoods may have further restrictions on what is permissible and whichever is the strictest, is the one that governs. I hope this has helped the application process for your new deck or patio.

## COMMUNITY REVIEWS ARE DONE!!

The 2017 Community Reviews and Follow Up Reviews are done. This year's process has been sped up dramatically with the help of my two assistants Jenn & Susan. We are currently working on sending certain lots that have not completed their 2017 review items to Formal Hearing with the Board of Directors. Please note that the review process does not stop just because it is now winter. Although 2017 main reviews have been completed, we are continuously noticing violations while on the property. We will also continue to do rear inspections from the Golf Course for neighborhoods that were not reviewed last year. You may receive a letter from us this winter asking for certain items to be done by the spring. This way, the item doesn't become worse over the winter. Some of the main items I will be looking for are:

- 1) Roof stains: If you have roof stains, the best thing you can do is hire a professional to clean your roof that knows to clean the roof without damaging the shingles. Most contractors use chemicals that remove the stains immediately, which is the preferred method. However, some contractors use a "spray and forget" type of chemical which takes a long time for it to work until the stains are completely removed. Sometimes it may even take a second or third application to remove the stains completely. If the stains are still not removed at the time of re-inspection you will be cited again until they meet Kiln Creek Standards (no stains/streaks/dark spots).
- 2) Algae on the siding and in the seams of the siding: If there is any sign of algae on your home this winter, you want to remove it as soon as possible because it spreads rapidly and will more than likely be a large area by the spring. Even if the algae is only in the seams, it will spread fast during the wet, cold winter months.
- 3) <u>Worn/torn window screens</u>: During the 2017 Community Reviews we noticed that many homes have worn window screens being a community over 20 years old. If you get cited for worn window screens you will not need to replace them until they start to tear.

With the winter months upon us, some of the items on your community review will not need to be done for several months due to cold weather. If you need an extension, all you have to do is contact the HOA office or send a quick email to <a href="mailto:sherrill@kilncreek.org">sherrill@kilncreek.org</a>. We have a beautiful, award winning community that we all want to see stay that way! We thank you for your continued efforts and hard work in making Kiln Creek the Premier Community on the Peninsula!



## **Safety and Security Tips**

When you are away from home running errands or simply leave for work in the morning, the last thing you want to worry about is the security of your home. Visibly empty houses are prime targets for vandalism or break-ins, and the threat is real. According to the FBI, more than 2.1 million burglaries occurred in the U.S. in 2010, with an average \$2,100 dollar loss per incident.

Here are some helpful suggestions to prevent you from becoming a victim of a burglary or an act of vandalism:

- Turn down the volume on your answering machine and ringer so that it can't be heard outside
- Cover the windows in your garage door so no one can see that your car is gone.
- Lock all garage doors; do not rely on an automatic garage opener for security into the house.
- Install outdoor lighting (activated by a photocell or movement) to illuminate the area around your home at night. Check bulbs regularly.
- Promptly dispose of boxes/packing materials accompanying large purchases. Boxes left in plain view advertise the purchase of valuables in the home.
- Consider installing a security system that directly alerts police to intruders. Use it at night and every time you leave the home.
- Keep your window shades or coverings drawn closed, especially when you're not home. This helps to reduce the ability for others to see your personal belongings within your residence.
- Ensure no windows are left cracked or completely open, for extended periods of time. First floor windows can be an easy entry point from the exterior of a residence
- Shake up your routine. If you have a garage, park at least one car in it, whenever possible. By not parking your vehicle(s) outside regularly, you reduce the ability for criminals to monitor your routine, to include when you are home and when you are away
- Walk around your home and look at your yard. If bushes and shrubs obscure your windows and doors, trim them back. Burglars love to take advantage of the screening overgrown shrubs provide.
- Instead of keeping a spare key in a mailbox, under the doormat, or on a nail behind the garage, wrap the key in foil -- or put it in a 35mm film can -- and bury it where you can easily find it if you need it
- Place a métal or wooden rod inside the track of your sliding glass door.
  This will prevent would-be thieves from opening the sliding door from the
  outside
- Don't leave notes for service people or family members on the door. These act as a welcome mat for a burglar
- All exterior doors should have at least 1 inch thick dead bolt locks.
   Although more expensive than spring latch locks, dead bolts are much
   stronger and provide significantly more protection. When installing
   deadbolts, make sure to leave a minimal amount of space between the
   door and its frame, as this provides an opportunity for an intruder to pry
   the door apart. Doors can be reinforced with plywood or a piece of sheet
   metal.
- If you've just moved in, change the locks on all exterior doors. You'll never
  know who had access to the keys before you moved in. If you lose the
  keys to your house, you should also replace all the locks for the maximum
  home security.
- If your door has hinges on the outside of your house, an intruder can
  easily remove the hinge pin to gain entry. For optimal home security,
  remove the door and reset the hinges so that they are on the inside of the
  house.
























Anyone who has traveled the inner streets of many of the villages in Newport News the weekend after bulk trash pick-up has undoubtedly noticed an assortment of clear trash bags containing either grass clippings or leaves, depending on the time of year. In addition to the other yard waste like limbs and bushes, old mattresses, grills and assorted old appliances. All those things that make for a visually unappealing sight. Most us would like for our neighborhoods to be beautiful and inviting. For those unaware, the rules state that you can NOT place any of these items at the curb prior to 5pm Sunday the day before the bulk trash is scheduled to be picked up. Those who continue to not follow the rules will receive a letter stating that they are in violation and if they continue, they may be brought to a formal hearing with the Board of Directors where you may be fined up to \$10 per day per violation for up to 90 days or \$50 per occurrence.



## Questions and Answers From the Office

#### Q. What do I do if I lost my Rec Pass?

A. You should first call the office to check when your pass expires. You may be eligible to get an updated pass. If the expiration date is still valid, it will cost you \$10 to replace the pass.

#### Q. What do I do if a crime occurs in my house or neighborhood?

A. Call the Police ASAP! All crimes need to be documented to either Newport News or York County Police. Once you have reported the incident, please call the Kiln Creek office to notify us of the crime. Please be aware that calling the police is the most important step.

#### Q. If I am selling my home, how and when do I get a disclosure package?

A. Disclosure packages take 14 days (10 business days) to process, so we recommend ordering a disclosure a month prior to closing. You will need to have the OWNER fill out and sign the request form (which we can email you or get it on our website) and send it back to us if you can't make it in during business hours. You can now choose to get the book electronically for \$225, vs. the thick binder for \$250.

The Kiln Creek Owners Association website and Courier newsletter are important communication tools for our members and for those considering a move into our community. The most frequently cited attribute of our community is the abundant natural beauty and wildlife and family-friendly atmosphere. #### **Pet Owners:**

Please be mindful of others and clean up after your pet. We receive complaints of this nearly every week. Please curb your pets, and stay off any lawns that you do not have permission to go on. There are also doggy stations all along the walking trails. Your assessments help pay for this service, and pet waste is also a health hazard. Also, please do not just bag the waste and throw it in the bushes; put it in the trash bin. Remember, pets must be on a leash and accompanied by a responsible person at all times, except when in a fenced rear yard. Pets shall not be tethered.

#### **Roaming Cats/Pets:**

We have had a number of complaints recently about cats roaming throughout Kiln Creek. Please note that free roaming cats (or any pets) are prohibited in Kiln Creek. Please do not permit your pet to be outside without a leash, unless in a fenced yard. If you know of an owner who permits their pet to roam the neighborhoods, please report it immediately to our office. If you notice any feral animals, please contact animal control at 890-3601.

## Parking

We have had several complaints over the last few months regarding vehicles being parked in front of other resident's homes. Please note, if you live on a public street, anyone can park in front of your home. We do ask residents to please be mindful when parking in front of someone else's home; however, we cannot stop them from doing so.

If you are having trouble with the resident not adhering to our Parking Rules, the current Kiln Creek Rules state, "Curbside parking...is permitted when the vehicle is parked so as not to impede traffic or block access to trash bins, mail boxes, stop signs and driveways and so as not to damage vegetation. Vehicles may not be parked within fifteen (15) feet of fire hydrants. No parking on lawns, Common Areas or Neighborhood Common Areas shall be permitted." If the resident is not abiding by these rules, we can certainly send a notice.






